It was moved (Chalmers) and seconded (Hicks) to amend the 2018-19 budget to include \$427,000 for the purchase of a new engine All approved
- 8. Discussion and possible action regarding amendment to the 2019-20 budget. The loan from Classic Bank for the purchase of new equipment has been finalized. It was moved (Hicks) and seconded (Johnston) to amend the 2019-20 budget to include the \$105,804.30 loan from Classic Bank for the purchase of new equipment. All approved
- The Investment report for the fourth quarter of FY 2018-19 was presented by Treasurer Johnston. The Money Market account balance as of September 30, 2019 was \$172,259.39. It was moved (Baumann) and seconded (Chalmers) to accept the report as presented. All approved
- 10. Discussion and possible action regarding disposition of 2 engines and 3 tenders and purchase of 2 pumper/tankers and 1 super tanker. Chief Gill reported that the sales of the surplus vehicles are in process,

- 11. Monthly report from Bastrop County First Responders regarding emergency operations, response times, call volume and membership was presented. 229 total responses were reported for September with an average response time of 6 mins

 - a. Operations reports The September monthly Operations Report was presented.
 - b. Monthly Statistics 95 calls were reported in September. Average response time was 12 mins 3 sec.
 - c. Training Sheet metal on the Training building is being replaced
 - d. Management Activities The 2 year TCFP audit was completed
 - e. Personnel –20 applicants were interviewed for the new full time positions

- f. Equipment maintenance The starter was replaced and a large air leak was repaired on T243
