Notice is hereby given that a regular meeting of the Board of Commissioners of the Bastrop County Emergency Services District No. 2 will be held on July 19, 2022, at 7:00 p.m. at the ESD Station 4, 1432 N. State Highway 95, Bastrop, Texas, for the following purposes:

Members of the public will speak on an agenda item after comments on the item are called for by the presiding officer, but before Board discussion and consideration of the item.
