1. The meeting was called to order by President George Martinez at 7:01 p.m.

6. Conduct public hearing on proposal to increase property taxes.

7. Discussion and action on Resolution Adopting Budget for fiscal year October 1, 2023 to September 30, 2024.

A Resolution adopting the budget was introduced for the consideration of the board. It was move and seconded that the Resolution Adopting Budget ("Resolution") be adopted, and after discussion the motion prevailed and carried by majority vote.

Tommy Chalmers moved to adopt the budget as presented totaling \$3,796,973.08 Doug Kelsay seconded After discussion with updates from Office Manager Lisa Ellers, Doug Kelsay moved to amend

the motion to reduce the Workman's Compensation by \$20,000 and to leave the difference in "general funds", the total budget unchanged.

Peter Hicks seconded the amending motion

The amended motion passed.

Peter Hicks moved to accept the Certificate of Resolution Tommy Chalmers seconded. The motion passed.

8. Discussion and record vote on District's 2023 tax rate, adopt an Order Levying Taxes, and authorize filing Order with Bastrop County Tax Assessor/Collector.
