A tax rate of \$0.100000 per \$100 valuation has been proposed by the governing body of **Bastrop County Emergency Services District No. 2.**

PROPOSED TAX RATE \$0.100000 per \$100 NO-NEW-REVENUE TAX RATE \$0.100020 per \$100 VOTER-APPROVAL TAX RATE \$0.103878 per \$100

The no-new-revenue tax rate is the tax rate for the 2025 tax year that will raise the same amount of property tax revenue for Bastrop County Emergency Services District No. 2 from the same properties in both the 2024 tax year and the 2025 tax year.

The voter-approval tax rate is the highest tax rate that Bastrop County Emergency Services District No. 2 may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is not greater than the no-new-revenue tax rate. This means that Bastrop County Emergency Services District No. 2 is not proposing to increase property taxes for the 2025 tax year.

A PUBLIC MEETING TO VOTE ON THE PROPOSED TAX RATE WILL BE HELD ON <u>Tuesday</u>, <u>September 16</u>, <u>2025</u>, <u>at 7:00 p.m.</u> at the Bastrop County ESD#2 Station 4, located at 1432 N. State Highway 95, Bastrop, Texas 78602.

The proposed tax rate is also not greater than the voter-approval tax rate. As a result, Bastrop County Emergency Services District No. 2 is not required to hold an election to seek voter approval of the rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the Board of Directors of Bastrop County Emergency Services District No. 2 at their offices or by attending the public meeting mentioned above.

Property tax amount = (tax rate) x (taxable value of your property) / 100
